RESOLUTION NO. 2016-01

BE IT RESOLVED, BY THE TOWN COUNCIL OF THE TOWN OF SECTION, ALABAMA, AS FOLLOWS:

- I. THAT THE TOWN AUTHORIZES THE LADD ENVIROMENTAL CONSULTANTS, INC TO APPLY FOR THE ALABAMA DEPARTMENT OF ECONOMIC AND COMMUNITY AFFAIRS (ADECA) FROM THE RECREATIONAL TRAILS PROGRAM IN THE AMOUNT OF (\$35,000.00); AND
- II. THIS FUNDING, IF AWARDED, WILL BE USED FOR THE WALKING TRAIL CONSTRUCTION IN WEATHING PARK; AND
- III. IF (ADECA) FUNDING IS AWARDED, THE TOWN AGREES TO PAY REQUIRED EXPENSES, INCLUDING BUT NOT LIMITED TO, (\$13,070.00) 20% MATCHING FUNDS; AND
- IV. THAT THE (ADECA) APPLICATION BE EXECUTED IN THE NAME OF THE TOWN OF SECTION, BY ITS MAYOR, FOR AND ON ITS BEHALF; AND
- V. THAT THE AGREEMENT BE ATTESTED BY THE TOWN CLERK AND THE SEAL OF THE TOWN OF SECTION AFFIXED THERETO; NOW THEREFORE

BE IT RESOLVED, THAT UPON THE COMPLETION OF THE EXECUTION OF THE AGREEMENT BY ALL PARTIES, THAT A COPY OF THE AGREEMENT BE KEPT ON FILE BY THE TOWN CLERK.
