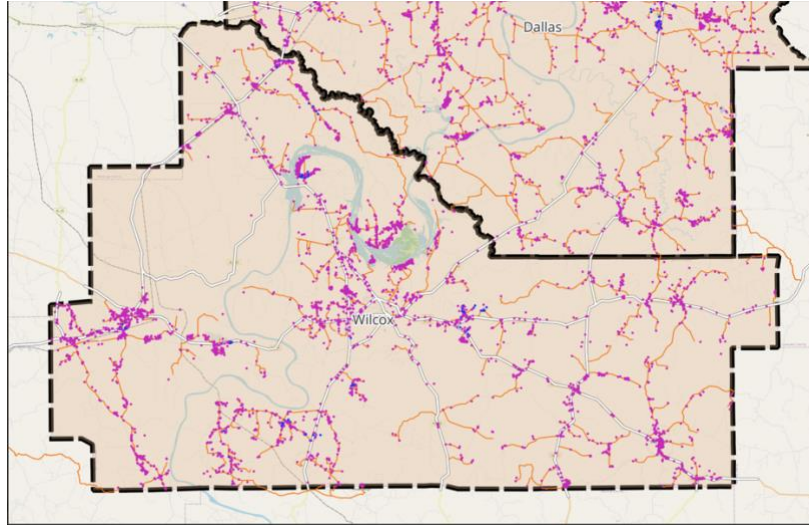

The underserved county of Wilcox faces a significant disparity in internet access, with a large number of locations receiving less than 100/20 Mbps. The table provided below outlines the extent of the underserved areas in each county:
