Q3. Does this project serve locations with demonstrated community support?

The support for the Tombigbee project has been nothing but overwhelming. Community leaders have come to the Board and management team consistently asking them to help their community by building our network in each of their areas.

Congressman, Robert Aderholt, State Senator, Larry Stutts, Alabama Representative, Jamie Kiel, and Alabama Representative Proncey Robertson along with many other state and community leaders have met with the management team and Board of Tombigbee stressing the need Franklin County has for broadband internet. This has been an ongoing conversation since the inception of freedomFIBER in 2017. The Franklin County Chamber of Commerce and the Franklin County Development Authority speak of the many challenges, specifically the lack of high-speed internet services, faced when trying to recruit new industry to the region as well as the student challenges today in the face of the pandemic (See Attachment C - Other Priorities Question 3 - Franklin Chamber of Commerce.pdf and Attachment C – Other Priorities Question 3 – Franklin County Development Authority.pdf)

Fire Chief Mike Rice of the Phil Campbell Fire Department and Mary Glass of the Franklin County EMA speak of the challenges they face with emergency management without access to high speed internet (See Attachment C – Other Priorities Question 3 – Phil Campbell Fire Chief.pdf and Attachment C – Other Priorities Question 3 – Franklin County EMA.pdf).

Forty-seven teachers from the Phil Campbell School system as well as the superintendent of the Franklin County School System have independently signed letters of support for this project. The Franklin County Water Authority has been tasked with finding a way to provide the residents of Franklin County with reliable high speed internet and have been working mercilessly for more than 4 years to try to make this happen.
