SUBJECT: State of Alabama's PY2023 CDBG Grant Application Workshop and

The ADECA Community and Economic Development Division (CED Division) will conduct the PY2023 CDBG Program Grant Application Workshop on Friday, April 28, 2023. This will be both an "in-person" workshop and a "virtual" workshop that will begin at 9:30 a.m. and conclude at approximately 3:00 p.m. The workshop will be held at the Alabama Center for Commerce Building located at 401 Adams Avenue, Montgomery, Alabama, in the 7th Floor Auditorium. The parking deck is located at 400 Adams Avenue, and you can enter the parking deck on the Decatur Street side using the following code: **369963**. All persons planning to attend the workshop "in person" should pre-register by 4:00 p.m. on Wednesday, April 26, 2023, by emailing Ms. Tonika Prince at Tonika.prince@adeca.alabama.gov. The workshop will also be accessible via WebEx on the same date and time identified above. All persons planning to attend the workshop "virtually" will need to register at https://bit.ly/FY2023_CBDGGrantApplicationWorkshop_2023-04-28, and upon registration completion you will be forwarded a link to access the workshop.
